

## BOARDING DISCLOSURE AGREEMENT

This Agreement applies to all boarding visits by your cat(s) to Molitor Pet & Bird Clinic, and every condition must be initialed in order for pet(s) to be admitted.

**Please initial next to each point to indicate you have read and understand the following:**

\_\_\_\_\_ I am the legal owner or authorized by the legal owner(s) of the cat(s) described on the Boarding Admittance Form.

\_\_\_\_\_ My cat(s) is/are in good health, free of fleas and ticks, and has not been ill within the past 30 days.

\_\_\_\_\_ I understand that while my cat(s) are boarded at Molitor Pet & Bird Clinic there is a small risk that my cat(s) may contract a contagious disease or illness. I agree that should this occur, I am responsible for my own pet's care, medical attention, and costs.

\_\_\_\_\_ I understand that the maximum nightly stay at Molitor Pet & Bird Clinic is up to, and no more than 3 nights.

\_\_\_\_\_ In the event of a medical emergency, I understand that Dr. Molitor and the staff will administer emergency medical care to the pet(s) at cost to the owner.

\_\_\_\_\_ I release Molitor Pet & Bird Clinic, its staff, and owners from any and all liability which I or my cat(s) may suffer, including but not limited to injury, sickness, damage, or death.

\_\_\_\_\_ I understand that my pet will be kept in a kennel, and will not be supervised before 8 am and after 5 pm on business days. On days Molitor Pet & Bird Clinic is closed, a staff member will be in to feed, provide fresh water, medicate if necessary, and clean your pet's kennel, but your pet will be unsupervised otherwise.

\_\_\_\_\_ I understand that the staff members of Molitor Pet & Bird Clinic will make every attempt to orally medicate your pet, but if your pet poses a safety risk to staff members we will use injectable medication from our in-house pharmacy at the cost to the client.

\_\_\_\_\_ In the event that I or my authorized contact cannot pick up my cat(s) at the agreed pick-up time, there will be a warning the first occurrence, a \$15 fee at the time of the second occurrence, and on the third occurrence you will be charged \$30 and your pet(s) will no longer be able to board at Molitor Pet & Bird Clinic.

\_\_\_\_\_ I understand that pick-up and drop-off will only be available when the Molitor Pet & Bird Clinic staff is in office, and **will not be available Thursdays, Sundays, and Holidays**. If you would like your pet(s) to be boarded and the time frame falls on one of these days, your pet will be required to stay another night awaiting Molitor Pet & Bird Clinic staff's arrival the following business day at cost to the owner. Boarding will not be available if Molitor Pet & Bird Clinic is closed for two days or more.

\_\_\_\_\_ In the event of pet(s) being abandoned at our clinic, the Molitor Pet & Bird Clinic staff will make every attempt to contact the owner. If we are unable to reach the owner(s) after one week, I understand that Molitor Pet & Bird Clinic will make every attempt to place the pet(s) in appropriate homes. In this event and this event only, I release ownership of my pet(s).
